PARTICIPANT AGREEMENT, RELEASE AND ACKNOWLEDGEMENT OF RISK

1. I acknowledge that target shooting entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. The risks include, among other things: accidental firearms discharges, ricochet bullets, hot shell cases, and faulty firearms/ammunition.

- 2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participating in this activity is purely voluntary, and I elect to participate in spite of the risks.
- 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Gulf Rifle & Pistol Club, Inc. from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Gulf Rifle & Pistol Club's equipment or facilities, including any such claims which allege negligent acts or omissions of Gulf Rifle & Pistol Club, Inc.
- 4. Should Gulf Rifle & Pistol Club, Inc or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs.
- 5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly or indirectly, by any such condition.

By signing this Document I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Gulf Rifle & Pistol Club on the basis of any claim from which I have released them herein.
